1. On 29 July 2026 a decision was issued in respect of these UK proceedings.

2. Paragraph 185 of that decision read:

“Mr Gawn has partially succeeded in his opposition against BHG’s trade mark application 3958917, which shall be registered for the following:”

3. I then provided a list of the terms for which 3958917 should be registered. Class 35 read as follows:

Class 35

Retail and wholesale services relating to the sale of towels, linens, bedsheets, cloth napkins, tea towels, footwear and headgear, carpets, rugs, mats and matting, linoleum and other materials for covering existing floors, wall hangings, not of textile, carpet tiles, vehicle mats and carpets, carpeting, fabric bath mats, textile floor mats for use in the home, bathroom tiles [carpet], carpet runners, textile wall coverings, floor tiles made of carpet, hand made woollen carpets, door mats of textile, parts and fittings therefor; retail services relating to the sale of household linen, curtains of textile or plastic, towels, linens, bedsheets, cloth napkins, tea towels, footwear and headgear, carpets, rugs, mats and matting, linoleum and other materials for covering existing floors, wall hangings, not of textile, carpet tiles, vehicle mats and carpets, carpeting, fabric bath mats, textile floor mats for use in the home, bathroom tiles [carpet], carpet runners, textile wall coverings, floor tiles made of carpet, hand made woollen carpets, door mats of textile, parts and fittings therefor, all the aforesaid provided via an electronic retailing Internet site; mail order retail services relating to household linen, curtains of textile or plastic, towels, linens, bedsheets, cloth napkins, tea towels, footwear and headgear, carpets, rugs, mats and matting, linoleum and other materials for covering existing floors, wall hangings, not of textile, carpet tiles, vehicle mats and carpets, carpeting, fabric bath mats, textile floor mats for use in the home, bathroom tiles [carpet], carpet runners, textile wall coverings, floor tiles made of carpet, hand made woollen carpets, door mats of textile, parts and fittings

therefor; retail services relating to household linen, curtains of textile or plastic, towels, linens, bedsheets, cloth napkins, tea towels, footwear and headgear, carpets, rugs, mats and matting, linoleum and other materials for covering existing floors, wall hangings, not of textile, carpet tiles, vehicle mats and carpets, carpeting, fabric bath mats, textile floor mats for use in the home, bathroom tiles [carpet], carpet runners, textile wall coverings, floor tiles made of carpet, hand made woollen carpets, door mats of textile, parts and fittings therefor, all the aforesaid provided via the telephone.

4. The specification for class 35 should have included 'household linen' and 'curtains of textile or plastic' in respect of retail and wholesale services, as it does for retail via electronic retailing internet sites, mail order retail services and telephone retail services.

5. Accordingly, the specification for class 35 should have read:

Class 35

Retail and wholesale services relating to the sale of household linen, curtains of textile or plastic, towels, linens, bedsheets, cloth napkins, tea towels, footwear and headgear, carpets, rugs, mats and matting, linoleum and other materials for covering existing floors, wall hangings, not of textile, carpet tiles, vehicle mats and carpets, carpeting, fabric bath mats, textile floor mats for use in the home, bathroom tiles [carpet], carpet runners, textile wall coverings, floor tiles made of carpet, hand made woollen carpets, door mats of textile, parts and fittings therefor; retail services relating to the sale of household linen, curtains of textile or plastic, towels, linens, bedsheets, cloth napkins, tea towels, footwear and headgear, carpets, rugs, mats and matting, linoleum and other materials for covering existing floors, wall hangings, not of textile, carpet tiles, vehicle mats and carpets, carpeting, fabric bath mats, textile floor mats for use in the home, bathroom tiles [carpet], carpet runners, textile wall coverings, floor tiles made of carpet, hand made woollen carpets, door mats of textile, parts and fittings therefor, all the aforesaid provided via an electronic retailing Internet site; mail order retail services relating to household linen, curtains of textile

or plastic, towels, linens, bedsheets, cloth napkins, tea towels, footwear and headgear, carpets, rugs, mats and matting, linoleum and other materials for covering existing floors, wall hangings, not of textile, carpet tiles, vehicle mats and carpets, carpeting, fabric bath mats, textile floor mats for use in the home, bathroom tiles [carpet], carpet runners, textile wall coverings, floor tiles made of carpet, hand made woollen carpets, door mats of textile, parts and fittings therefor; retail services relating to household linen, curtains of textile or plastic, towels, linens, bedsheets, cloth napkins, tea towels, footwear and headgear, carpets, rugs, mats and matting, linoleum and other materials for covering existing floors, wall hangings, not of textile, carpet tiles, vehicle mats and carpets, carpeting, fabric bath mats, textile floor mats for use in the home, bathroom tiles [carpet], carpet runners, textile wall coverings, floor tiles made of carpet, hand made woollen carpets, door mats of textile, parts and fittings therefor, all the aforesaid provided via the telephone.

6. The appeal period is not affected by this correction.
